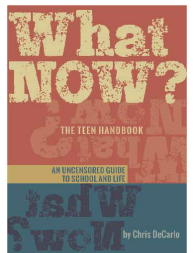

Sheriff's constitutional role in protecting your democracy

Dear Voters of Fairfax City and County,

I am an independent candidate for sheriff to offer a more permanent solution to the frustration we all feel by promoting the concept that the constitutional Office of Sheriff, as provided in the Virginia Constitution, has the authority and power to improve our trust in our local, state, and federal government's if only the sheriffs would exercise it. I believe that Sheriffs can improve the self-governing process by stopping the flow of campaign money that diminishes the power of the people. You can't fix something unless you know how it works and corrupted governance works because bribes have been legalized as campaign contributions.

**The introduction of campaign contributions
into the election process is an oxymoron to the
democratic principles the Constitutions create.**

So what do you think? Do campaign contributions dilute your power to control your government? Do contributions serve the common good? Can and should the sheriff charge elected officials for bribery, treason, and sedition?

I think that sheriffs can and should fix America because they take an oath to protect the power of the people and they have the power of arrest both of which make sense in providing citizens a law enforcement mechanism that is accountable via election to them. But it seems that this concept may not be practiced because sheriffs are accepting contributions also.

I argue that a corrupt government is not going to educate its citizens about its dysfunction or to teach them about how it can be corrected.

All of my independent candidacies have been to fight political corruption. Corrupted governance is just the same here in Virginia and D.C. as it is in throughout America, well organized and well hidden.

In my campaigns I have argued that disclosure of contributions does not make them constitutional. Nobody has ever questioned or disagreed with my thesis.

As explained to me by several sheriff deputies, sheriffs are our chief law enforcement officer in each county, and as Constitutional Officers, they have a higher authority than the local police, the state police and even federal agents such as the FBI. State and Federal law enforcement has to get permission from the sheriff before they can take action in a jurisdiction. This legal interpretation was explained to me by sheriff deputies who act at the pleasure and in place of the actual sheriff.

Sheriffs are classified as Constitutional Officers. “Constitutional” referring to the jurisdictional State Constitution, not the Federal Constitution, but I believe their jurisdiction can translate to the Federal Constitution also via the State Constitution. All sheriffs take an oath to uphold and protect your State and Federal Constitutions, you and your power (the power of the people) and your rights (to control your government vis-a-vis elected representatives). So I ask, with all the money flowing into political campaigns, where are our sheriffs when we need them and their authority the most?

Your local sheriff is supposed to be accountable to the citizens that elect him, or her, as protector of their constitutional rights because they are the only law enforcement officer that we elect and, via election, they are supposed to be responsive to your needs. By comparison, county police are controlled by a Chief of Police that is controlled by your County Board which is a political entity and the city police are controlled by a Chief of Police that is appointed by the City Council which is also a political entity.

**The sheriff is your only law enforcement officer
that is directly elected by the citizens.**

To help put the distinction and significance of having your chief law enforcement officer directly elected by the people in a better perspective, consider that when the Constitution was written that the guys who wrote it knew all about corruption and how they needed a decentralized way to help insure that the government they were creating wouldn't become corrupted. They also had the legal roles of sheriffs in England to serve as a guide.

It makes sense that the local sheriff had to protect the State as well as the Federal Constitution because who else was going to do it? Travel by horse took a long time and the sheriff was the best person to give the authority so he could make sure the government and its legislators did not subrogate the power the people gave them to monied interests. So the Office of Sheriff is molded as the decentralized protector of freedom and democracy. It all makes sense for the time of the 1700's and even more so for today.

By comparison, modern times for today's sheriffs are a lot different in that our representatives and our governments accept lots of money while the sheriffs in metropolitan areas are relegated to running the jails and protecting the courts. This leaves the government free to do as it pleases without regard for the power the people place with their elected representatives each election cycle.

**I argue that citizens have been conditioned to think that the Federal government is
supreme and the schools don't teach anything about State Constitutions and the roles of the
local Constitutional Officers as provided in the documents
to perpetuate the myth.**

For a country that says it is so concerned about promoting democracy it seems that it has skipped a few steps when it comes to educating its own. The citizens have been bamboozled out of their real constitutional power as provided in the Federal and State Constitutions even though it is still there. Citizens will be second class as long as influence money is available to the leadership. And if passive or incompetent sheriffs are recruited by the party elite, they are not going to challenge or bite the hand that feeds them. The real constitutional power of the sheriffs is still valid, its just been obscured.

I have always assumed that all countries had sheriffs like we do, only to find that they don't. It turns out that most other constitutions, such as for Central American and European countries, do not have a provision for sheriffs. This means that the citizens do not have any elected law enforcement person that is accountable to them, vested with the legal authority to protect them and their constitution. Maybe the lack of an Office of Sheriff is why corruption is so systemic throughout the world and why so many citizens from Central America are driven to try and immigrate to America.

I hope you can use this information to better protect your rights with a better understanding of how and why your governments function and what they may be doing right and wrong.

**Your sheriff is your only hope for protecting your
rights to have a truly representative government but it
seems that few of the sheriffs can or are willing to fulfill
all the duties of the Office as originally intended.**
